- 1) **Trend of COVID-19 cases/positive COVID-19 tests**
Slightly different approach this week. As I have mentioned in the past, numbers fluctuate from day to day but the overall trend is a steady increase. This week I will be reporting seven-day averages to better reflect that. The seven-day average percent positive has increased over the past week from 8.6 to 14.9%. The seven-day average for cases per million has increased from 421 to 729. We had over 350 cases in the past 7 days – another new record. We are at over 1000 cases since October 1. It took us from March to October to get to 350.
- 2) **Hospitalizations due to COVID-19**
Eight at SIH in the past week. Please recall that, regardless, SIH is not a great indicator because they usually transfer COVID patients rather than admit them. Also please remember that hospital admission numbers can change rapidly. However, the take-home message is that hospitalizations continue to be elevated compared to earlier in the year. In addition, as with many of you, staffing is an issue for hospitals as more staff test positive.

- 3) **Number of deaths resulting from COVID-19 in the past 14 days**
Four for Ionia County
- 4) **COVID-19 cases for each day for every one million individuals**

- 5) **Percentage of positive COVID-19 tests over a four-week period**
Increased from 4.6 to 14.9% (seven-day average) from October 16th to November 16th
- 6) **Health Care capacity strength**
Nobody knows what this means because the legislature did not define it.
- 7) **Testing, tracing, and containment infrastructure with regard to COVID-19**
Sparrow is increasing capacity to decrease turnaround times. The Health Department is also looking to add to testing capacity with a third-party vendor. We began texting “non-priority” cases this week and limiting the number of calls that we make, and we are starting to get caught up as a result. Containment infrastructure is weak. We have no way to know if most people are truly complying with quarantine and isolation. This is a problem across the State.

High schools are now virtual and many of you have gone virtual for other grades. K-8 can remain open provided there is no active transmission in the building. For purposes of the matrix that I (Ken Bowen) sent out, we are in Risk Category E as a County.
